## 1. PREAMBLE

- iv. The prices quoted must be inclusive of all taxes, cost of software, training /machine demonstration, loading & unloading, transport insurance (wherever applicable) and transportation charges to deliver the equipment/machine at the CFC address.
- v. In case of discrepancy between the prices quoted in words and figures lower of the two shall be considered.
- vi. If a bidder quotes NIL charges/consideration, the bid shall be treated as unresponsive and will not be considered.

- ii. The comparison of the rates offered shall be based on the total all inclusive rates offered (i.e. sum of all inclusive rate offered for all the tendered items).

## **16. AWARD OF CONTRACT**

- i. The Bidder who has quoted lowest price (L1) will be issued the 'Letter of Acceptance' by the Implementing Agency.
- ii. In unavoidable circumstances, such as receipt of very limited bids or the proposal prices are substantially higher than the market value / updated cost estimate or available budget, the committee may decide upon resorting to Negotiation with the lowest evaluated responsive bidder. In such cases, the Bidder who has quoted lowest price (L1) will be invited for negotiations and after finalizing the negotiated rate, Letter of Acceptance will be issued.

## **17. SECURITY DEPOSIT**

- i. On receipt of the Letter of Acceptance from IA, the successful bidder should remit a Security Deposit (SD) of **3%** of the value of the contract in the form of Account payee Demand Draft from any

Specialized Institutional Banking Branch or irrevocable Bank Guarantee with a validity period of one year in favor of “**FREEDOM FREE DUTY OF MANKIND**” (IA), within 10 (Ten) working days from the date of receipt of letter of acceptance. The EMD shall be adjusted with the Security Deposit.

- ii. Any other amount pending with IA will not be adjusted under any circumstances, against the Security Deposit if so requested.

## **22. TRAINING OF STAFF**

The working committee reserves the right to reject in full or part, any or all bids without assigning any reason thereof. The working committee reserves the right to assess the Bidder's capability and capacity. The decision of the working committee shall be final and binding. Bid should be free from overwriting. Offers not submitted in prescribed manner or submitted after due date and time are liable to rejection.

## **28. GENERAL CONDITIONS**

- i. Conditional tender in any form will not be accepted.
- ii. Any notice regarding any matters, to the contractor shall be deemed to be sufficiently served, if given in writing to his usual or last known place of business.
- iii. Tender committee reserves the right to relax or waive or amend any of the tender conditions.
- iv. The successful bidder shall not outsource/off load either full or part of the work to any other agency / individual.
- v. If the performance of the bidder is not as per the schedule, then tender committee reserves the right to cancel / reallocate full or part of the contract, at any stage of the contract execution.

## **29. ARBITRATION**

- i. In case of any dispute in the tender, including interpretation, if any, on the clauses of the tender or the agreement to be executed, the matter shall be referred by IA / Bidder to an Arbitrator to be appointed by the Parties hereto by mutual agreement. If no such Arbitrator could be appointed by mutual consent, the matter may then be referred to **(NA) IGTR, INDORE** for nominating an Arbitrator, the Arbitration proceedings being governed by the Arbitration and Conciliation (Amendment) Act 2015.
- ii. The venue of the Arbitration shall be at **(NA) IGTR, INDORE**. The decision of the Arbitrator shall be final and binding on both the parties to the Arbitration.
- iii. The Arbitrator may with the mutual consent of the parties, extend the time for making the award. The award to be passed by the Arbitrator is enforceable in the court at **ODISHA**.

## **30. JURISDICTION OF THE COURT**

Any dispute arising out of non-fulfillment of any of the terms and conditions of this Agreement or any other dispute arising out of the arbitration award will be subject to the jurisdiction of the Courts in the City of **ODISHA** only.
